2. Review/Approve Minutes from 9/28/2021

a. Approved

3. Person Data Domain and Operating Committee Approval

- a. Cathy reviewed Jocelyn's comments for the group.
- b. The council agreed that Cathy will send out the revised draft with Jocelyn's suggested changes, provide twenty-four hours to see if there are other changes, and then move forward with approval between the meetings.

4. <u>Data Documentation Standard Review and Feedback (Michelle Young & Elizabeth Simcock)</u>
