## 2. RADAR Mini-Rebrand

a. RADAR acronym now stands for "Repository for Administrative Data and Reports."

## 3. UW System Enterprise Data Governance Council

- a. Enterprise Data Analytics Platform (EAP)
  - i. Support ATP by building a warehouse/data lake for archived PeopleSoft data and future data from Workday and other systems.
  - ii. Work with Interop to support/reduce number of ancillary systems System-wide (ASP project)
  - iii. Establish System-level data governance program
    - 1. Hiring Data Governance Analyst position
- b. Enterprise Data Governance Council (EDGC)
  - i. Launched Feb. 2023
  - ii. Scott Owczarek is a council member representing the Registrar's Office.
  - iii. 1<sup>st</sup> resolution for the EDGC is to deploy a data classification schema for ATP/EAP/ASP. SYS-1031 policy uses a different schema from UW-Madison (UW-504).
    - 1. Madison's current classification system: Restricted, Sensitive, Internal, and Public
    - 2. System's classification system: High Risk, Moderate Risk, Low Risk
    - 3. Possible crosswalk between the two depending on what is decided.

### 4. <u>Proposal for Ad Hoc Subcommittee: Appropriate Use of Teaching & Learning Data</u>
